The board has performed a lot of work around the exam with the pass rates in mind and many hours from many volunteers went into this process. Much of the last 2 years has been focused on the Practice Analysis, reviewing exam items, updating handbooks, exam development and standard setting. ALL current exam items have been reviewed for relevancy and accuracy, confirmed outline classification, improved and deleted some exam items, and any changes were placed back into pre-test mode. We would also like to welcome and thank our new testing provider, ASC, for their guidance and ensuring candidates receive their test scores quicker. ABOHN staff have completed the move to a 100% virtual office.

Did you know? ABOHN has partnered with ISU and CSU and their Occupational Safety Management Programs to offer work hour credit for their course work. Course work can now be used to offset the 3000 work hours needed to apply for certification in addition to other eligibility criteria. This allows for another path for credentialing!

I would be remiss if I didn't thank our Executive Director, Betty Sanisidro. She has spent tireless hours making our organization better than it was and continues to look for areas where we can improve for the sake of our certificants and applicants.

Looking forward, there is still a lot of work to be done and many OHNs and employers to reach and educate about the power of credentialing. ABOHN continues to seek opportunities to get in front of and network with as many people as possible to promote our goal of education and credentialing.


